Abstrak:

Kajian ini dijalankan bagi meneroka pengalaman dan amalan kepimpinan tertinggi Majlis Belia Malaysia (MBM) menerajui Pembangunan Belia Positif (PYD) yang merupakan teras utama Dasar Belia Malaysia (DBM) 2015-2035. Ulasan kepustakaan dan penilaian awal telah dibuat mengenai senario pembangunan belia, model program belia dan program serta aktiviti yang telah dilaksanakan oleh MBM daripada pelbagai sumber rasmi sekunder bagi membuka laluan bagi pelaksanaan suatu kajian lapangan yang lebih komprehensif berkaitan pengetahuan, amalan dan cabaran kepimpinan tertinggi MBM menerajui PYD yang menjadi teras utama DBM dalam senario semasa pembangunan belia. Soroton literatur kajian ini dapat dirumuskan bahawa MBM merujuk DBM yang berteraskan PYD dalam setiap perencanaan dan perancangan programnya namun tidak secara sistematis, strategik dan serius dalam merangka programnya, menyebabkan program banyak bersifat ad hoc dan tidak benar-benar dapat menyerlahkan potensi belia dan mencapai Matlamat 8C. Rumusan awal berdasarkan ulasan kepustakaan juga mencadangkan agar amalan terbaik bagi MBM menghasilkan Matlamat 8C dalam setiap program dan aktivitinya adalah dengan merujuk DBM sebagai input dan mengaplikasikan Model Perencanaan Program Interaktif Caffarella dalam proses perencanaan dan perancangan.

Abstract:

This study was conducted to explore the experiences and practices of the top leadership of the Malaysian Youth Council (MBM) in leading Positive Youth Development (PYD) which is the main core of the Malaysian Youth Policy (DBM) 2015-2035. A literature review and initial assessment have been made on the youth development scenario, youth program model and programs and activities that have been implemented by MBM from various secondary official sources to pave the way for the implementation of a more comprehensive field study related to the knowledge, practices, and challenges of the top leadership of MBM leading PYD which is the main core of DBM in the current scenario of youth development. The highlights of the literature of this study can be summarized that MBM refers to DBM based on PYD in every planning and planning of its programs but not systematically, strategically, and seriously in designing its programs, causing many programs to be ad hoc and not really able to highlight the potential of youth and achieve 8C. The initial formulation based on literature review also suggests that the best practice for MBM to produce 8C in each program and activity is to refer to DBM as input and apply the Caffarella Interactive Program Planning Model in the planning and planning process.
